## Part A: Pupil premium strategy plan

### Statement of intent

At Ropery Walk Primary School, we believe that teaching and learning opportunities should meet the needs of all pupils. We strive to ensure that appropriate provision is made for pupils who belong to vulnerable groups, ensuring that the needs of such pupils are adequately addressed and support is put in place. Our work with children in receipt of Pupil Premium is aimed at accelerating progress and overcoming barriers to learning so that these pupils achieve similar outcomes to their peers and diminish the difference between Pupil Premium and non-Pupil Premium children.

## **Challenges**

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Pupils who are eligible for Pupil Premium tend not to enter EYFS at agerelated expectations and communication and language is exceptionally poor. This means there is already a gap between Pupil Premium and non-Pupil Premium children on entry to school. We need to ensure they make more progress than their peers to catch up.
2	Disadvantaged children may have less general knowledge, vocabulary and experiences which may make it difficult for them to acquire more knowledge or access books and curriculum
3	A lack of engagement and supportfrom families at home means staff have to build opportunities in school to support and develop a love of learning, especially reading.
4	Some Pupil Premium children may have emotional and social challenges which can interfere with learning.
5	Low attendance rates for some Pupil Premium children impacts on their learning. This means they are constantly having to catch up to their peers.

### Intended outcomes

## Part B: Review of the previous academic year 2023 - 24

## **Outcomes for disadvantaged pupils**

This summary details the impact that our pupil premium activity had on pupils in the 2023 to 2024 academic year.

#### Phonics:

Multiplication: 100% achieved their Multiplication Tables Check this year with an average score of 24.4 compared to a national average of 20 for August borns and 20.9 for September borns.

#### KS<sub>2</sub>

In year 6, 19 pupils (41%) were considered disadvantaged compared to a national average of 31% of pupils.

In 2024, KS2 attainment for all pupils at the expected standard in RWM combined was 60% which was just below national (61%). Nationally, 45% of disadvantaged pupils met the expected standard in 2024 compared to 67% of other pupils. \_\_\_\_ of our disadvantaged pupils met standard. both increasing by 1 percentage point since 2023, keeping the gap at 22 percentage points.

#### **Teaching Strategies**

Through keeping class sizes small, teachers have been able to use adaptive teaching to closely tailor lessons to children's needs. Outcomes have therefore been successful with all pupils making good progress.

Work around KIRFs in Maths has helped teachers to closely monitor and prioritise key outcomes upon which the children can build their learning as they move through the school and this can be seen in internal data.

Reading in class has been highly successful in engaging children in books and reading.

#### **Targeted Intervention**

#### Phonics:

Phonic interventions have been highly successful – 71% of our 17 disadvantaged children passed their phonics test compared to 68% nationally.

Impact on Learning and Engagement

Teachers say: 16 of 18 children were better after coming to Place2Be 3 children had difficulties that caused an impact on their classroom learning, 3 improved\*

Parents think: 16 of 16 children were better after coming to Place2B – this is a significant improvement of family engagement.
